We have 2 large conifers in the rear garden which are causing excessive shading to ours and neighbours gardens. I estimate they are 20m high and both are close to the fence. One is about 5m from a single storey extension and could cause subsidence in the future. I would not be replanting as there are another 3 conifers still in the garden and we back onto the woods and get a lot tree debris from trees growing next to our rear fence. We need to fell these 2 two conifers and both sets of neighbours would like them to go as well.
