TPO738 - Fell oak tree because it is lifting the patio, is too close to the house, is too close to mains drains and gives access to squirrels to the roof. The oak tree drops sizeable branches and debris on the roof and it provides unwanted excessive shade. The tree has little or no amenity value. It is not visible from the road, railway track or front of the house, except for the top. Neither neighbours, who can see it, think it has any amenity value and are happy for it to be felled. We have lived with this tree for 9 years. The roots are now pushing up the patio and it has got too big. We are very concerned that the roots will go into the drains which are only 1.25 metres away from the tree. The house is very close to the tree, being just over 3m away. We will replant an oak tree somewhere else in our garden where it will not cause damage.
