- T1 - 1 x Oak to reduce height by 1.5m to maintain size due to proximity to building
- T2 - 1 x Oak to reduce height by 1.5m and lateral growth by 3m to shorten growth over neighbours garden 7 balance
- T3 - 1 x Oak to remove epicormic growth, deadwood and clean out crown for safety
- T4 - 1 x Oak to to sever lve at base, remove epicormic growth, deadwood and clean out crown for safety
- T5 - 1 x Oak to remove bulk of lvy and sever at base, reduce by 1.5m height & width remove epicormic growth to maintain size due to proximity to building.
- T6 - 1 x Cherry to fell to ground level - poor form, canker around 5m
- T7 - 1 x Hornbeam to fell due to large decay at base
- T8 - 1 x Ash to fell due to poor form
- T9 - 1 x Cherry to fell - poor form and not much left if reduced
- T10/11 - 2 x Hornbeams to reduce back lateral growth by 3m to prevent debris & damage to garage roof
