We would like to remove a row of cypress conifers from along the edge of our rear garden. These trees are difficult to maintain properly, they are very close to trees in neighbouring Scholars Mews (which have TPOs) and they impact negatively on the growth of other plants/bushes in our garden. We would also like to remove an unsightly holly tree which is becoming entangled with a mature hornbeam tree behind it. None of these trees are subject to TPOs.
